"Overflow" pickleball players may use the tennis court, as long as there are no tennis players desiring to play. Tennis players will get priority use of the tennis court at all times.







Greetings,

After the discussion at the recent Board Meeting, I wanted to share some information with the Community regarding Open Meeting Law and reading/posting of Meeting Minutes. I am hoping that you will find this information helpful.

To fully understand how the law pertains to HOAs, it is first important to understand the "hierarchy of documents." In order of strength, the hierarchy is as follows:

- 1. Law (unless the particular law defers to the governing documents)
- 2. CC&Rs
- 3. Articles of Incorporation
- 4. Bylaws
- 5. Rules & Regulations

In other words, the Law (#1) trumps all HOA documents; the rules and regs has the lowest weight. So if the Bylaws are inconsistent with the CC&Rs (or any document above it on the list), the document above would override the lower document.

That being said, while Section 2.4 of our Bylaws, calls for "notice to be delivered by such means as permitted under Section 10.5, at least 10 but not more than 50 days before the date of such meeting," in this case, the law (specifically A.R.S. §33-1804(C)), would trump that requirement. This section of the statute states:

Notwithstanding any provision in the declaration, bylaws or other community documents, for meetings of the board of directors that are held after the termination of declarant control of the association, notice to members of meetings of the board of directors shall be given at least 48 hours in advance of the meeting by newsletter, conspicuous posting or any other reasonable means as determined by the board of directors. An affidavit of notice by an officer of the corporation is prima facie evidence that notice was given as prescribed by this section. Notice to members of meetings of the board of directors is not required if emergency circumstances require action by the board before notice can be given. Any notice of a board meeting shall state the time and place of the meeting. The failure of any member to receive actual notice of a meeting of the board of directors does not affect the validity of any action taken at that meeting.

It is very important to note that the statute is very clear that open meeting law only applies "After the termination of declarant control of the association."

ARS 33-1804(C) clearly states that the provision about 48 hour notice to members of meetings of the board applies only to meetings held "after the termination of declarant control". Therefore, Board meetings under declarant control can be held without notice to members. However, subsection A of the same statute says that meetings are open to all members and designated representatives. There is no language in that subsection about "after declarant control". Therefore, even if notice of a meeting is not sent or posted, if members can find out about the meetings they can attend. If meetings are noticed, then of course they can attend.

Regarding Posting of Meeting Minutes, Section 41 of Robert's Rules of Order states:

The practice of sending to all members [of the Board] advance copies of the minutes as drafted by the secretary has both advantages and disadvantages. It is natural for the members to prefer to study the minutes beforehand to be better prepared to offer corrections; and this procedure generally saves time when the minutes come up for approval. On the other hand, the minutes do not become THE minutes and assume their essential status as the official record of the proceedings of the society until they have been approved...

Regarding reading of the minutes, Section 48 states:

If the assembly [Board] does not wish to carry out the reading and approval of the minutes at the regular time, it may, by majority vote without debate, dispense with the reading of the minutes. The minutes can then be taken up by the majority vote without debate.

A draft of the minutes of the preceding meeting can be sent to all members [of the Board] in advance, usually with the notice. In such a case, it is presumed that the members have used this opportunity to review them, and they are not read unless this is requested by any member. Correction of them and approval, however, is handled in the usual way. It must be understood in such case that the formal copy placed in the minute book (or in our case published on the website) contains all corrections that were made and that none of the [prior] copies circulated to members and marked by them is authoritative.


So as a quick recap, since we are still declarant controlled, we are not legally bound by Open Meeting Law and the Board can conduct "association business" at any meeting (study session OR board meeting) and our meetings do not need to be noticed or "open". However, our board chooses to send notice of meetings for informational purposes and to encourage transparency. Further it is not recommended that minutes be posted or circulated to the community until they have been approved and become the official record of the meeting.



Restured Recipe







Ingredients

3/4 pound boneless skinless chicken breasts, cut into 1/2-inch cubes

4 tablespoons butter, divided

3 cups frozen broccoli florets, thawed

1/2 teaspoon onion salt

1/2 teaspoon dried thyme

1/2 teaspoon dried rosemary, crushed

1/4 teaspoon pepper

6 cups cubed French bread

2 eggs

3/4 cup 2% milk

2/3 cup condensed cream of onion soup, undiluted

1 cup (4 ounces) shredded Colby-Monterey Jack cheese

Directions

- 1. Preheat oven to 400°. In a 10-in. ovenproof skillet, sauté chicken in 2 tablespoons butter until no longer pink. Add broccoli, onion salt, thyme, rosemary and pepper; heat through. Remove from skillet and keep warm.
- 2. In same skillet, toast bread cubes in remaining butter until lightly browned. In a small bowl, combine eggs, milk and soup; pour over bread cubes. Stir in chicken mixture. Sprinkle with cheese.
- 3. Bake, uncovered, 15-20 minutes or until a knife inserted near the center comes out clean. Let stand 5 minutes before cutting.

Lawn and Garden

Life (Lawn & Garden) Style By Alexandria Masters

Ah, summer, what power you have to make us suffer and like it. ~Russell Baker

August means high summer, and lots of it! And it also means two things for any gardener: hot and dry! They don't call these the dog days of summer for nothing. But there is a lot to enjoy in August. Many plants are in bloom. The air is sultry. Lemonade and iced tea reign. Butterflies and hummingbirds are flitting around. It's also the last month before fall, school is starting up again, and our lives shift toward fall.

Need an August inspiration? Have a barbeque! Get out the citronella candles and sit outside with friends and family on these warm and starry nights. The bugs will be out, so keep your insect repellent close. By far, I would say the most important gardening tip for August is to sit back, relax, sip your lemonade, and admire the results that your months of hard work have awarded you.

Seasonal Suggestions for the month of August

Home: Watering your plants first thing in the morning will actually promote growth. Plants start to metabolize with the sunrise, therefore they best utilize their water intake at this time of day. Houseplants are no exception. Plants ought to be watered before 11am. Plants that are watered at night are more susceptible to fungus and diseases. I guess the doctors are right when they say that breakfast is the most important meal of the day, that includes your beloved plants.

Lawn: Water, water, just not too much! With the continuing hot weather don't be tempted to

Lawn: Water, water, just not too much! With the continuing hot weather don't be tempted to get your garden hose out and spray down your lawn. Light surface watering only encourages root laziness. This will make your lawn more vulnerable to drying out. Setting up a watering system will encourage roots to push into the ground for nutrients.

Garden: Every weed that produces seed means more trouble next year. Control weeds before they go to seed. They'll drop seeds for next year if allowed to flourish in the garden and lawn. Also, do not add weeds with mature seed heads to the compost pile. Many weed seeds can remain viable and germinate next year when the compost is used.

And... Deadheading your garden keeps it tidy and attractive. Do this daily to get the most blooms out of your plants. Most flowering plants benefit from cleaning. A little deadheading goes a long way towards productivity of blooms. As the blooms start to fade, brown, or just not look as beautiful as they should, trim them off. Use garden clippers to snip off the dead ends. This simple effort lets the other flowers shine.
